# For victims of sexual assault, domestic violence, dating violence and stalking

Individuals have many options with regard to reporting sexual assault, domestic violence, dating violence, and stalking, including reporting to the <u>Chicago Police Department</u>, and to TTIC authorities. Additionally, victims have recourse through the civil and criminal court systems by seeking orders of protection, no-contact directives, and other similar court orders. TTIC can also assist victims by making accommodations, such as class schedule changes, work reassignments and other changes. Victims also have the option to decline to notify authorities.

# Confidential Counseling and Advising

All confidential resources listed below provide 24-hour (7 days/week) crisis counseling and information regarding sexual assault, dating violence and stalking. Survivors and friends of survivors can call. These resources can also provide information on local hospitals, such as what hospitals will have a victim advocate or Sexual Assault Nurse Examiner (SANE) available.

#### Resilience

TTIC has partnered with <u>Resilience</u> to provide TTIC students with 24/7 access to a Confidential Advisor who can provide victims with information on both TTIC- and community-based resources and immediate referrals. It also provides long-term information on the rights of victims and TTIC's responsibilities regarding interim and long-term accommodations, orders of protection, no-contact orders, and other similar court orders. Resilience also provides medical and legal advocacy, and counseling services (individual and group). Services are free for survivors or friends/partners of survivors.

#### **Medical Assistance**

The fastest way to access medical assistance is to call 9-1-1. (From a TTIC phone, dial 9-9-1-1.)

The Mitchell Emergency Room follows specific policies and procedures, approved by the State of Illinois, in treating an individual who has been sexually assaulted. The State will pay for emergency room care

for victims who have been sexually assaulted and do not have health insurance; if a victim provides health insurance information to the emergency room, the emergency room will bill the insurance company and the policyholder will be notified as usual. These procedures include:

- The victim is placed in a private room.
- Medical care is given as soon as possible.
- A Sexual Assault Survivor Advocate or a Sexual Assault Dean-on-Call (for a student) may be called based on a victim's preferences.
- By law, city police are notified, and the victim may choose to file a report.

Under Illinois law, medical personnel are required to alert police when it reasonably appears that the person requesting treatment has sustained an injury as a victim of a criminal offense, including sexual assault or violence, but individuals have the right to refuse to speak to police.

### Law Enforcement Assistance

University of Chicago Police Department

The <u>University of Chicago Police Department</u> (UCPD) urges anyone who has been sexually assaulted to call immediately in order to strengthen the likelihood of successful prosecution. A UCPD officer can be summoned by calling 773.702.8181, pressing the red button on any of the emergency phones located throughout the community, or going directly to the UCPD office at 6054 South Drexel Avenue.

The UCPD recommends the prompt reporting of sexual assault, domestic violence, dating violence, and stalking. Nevertheless, individuals should not be reluctant to file a report at a later date. Reporting an incident does not obligate a person to press charges.

Responsibilities of the UCPD include:

- Attending to the immediate needs of the victim, including personal safety and prompt medical care.
- When appropriate, broadcasting a description of the offender.
- Providing victims with information concerning the importance of preserving evidence.

#### NOTE: A call to UCPD will trigger a report to TTIC.

#### Chicago Police Department

9-1-1 (24-hours) or 9-9-1-1 from a campus phone

Anyone preferring not to report a matter to the University of Chicago Police Department may contact the Chicago Police Department.

NOTE: A call to CPD may trigger a report to TTIC.

## Reporting to TTIC

Individuals who believe they have been victims of sexual misconduct can raise concerns or file a complaint regarding a faculty member, academic appointee, staff member, student, visitor, contractor or third-party under the <u>Sex Discrimination</u>, <u>Sex-Based Harassment</u>, <u>and Pregnancy Modifications Policy</u>. Third-party bystanders may also file a complaint.

Individuals can report sexual misconduct by:

- 1. Submitting a complaint via the <u>Harassment Reporting Form</u> on the TTIC website. Anonymous reporting is available.
- 2. Contacting the Title IX Coordinator or Deputy Title IX Coordinator.
